

Itu tahapan indeksasi jurnalnya. Tulisan ini sekedar catatan saja syarat-syarat apa yang perlu disiapkan agar bisa terindeks pada situs-situs tersebut. Tulisan ini terinspirasi dari pertanyaan seseorang yang masuk ke email saya. Agar tidak salah paham, tulisan ini sekedar catatan saja dan saya bukanlah seorang yang ahli dalam hal ini.

## **Cara agar Terindeks di Google Schoolar**

Perhatikan hal-hal di bawah ini:

1. Sangat disarankan untuk menggunakan aplikasi Open Journal Systems yang dibangun oleh Public Knowledge Project. Dapat diunduh di <https://pkp.sfu.ca/ojs/>.
2. Baca Inclusion Guidelines for Webmasters di sini <http://scholar.google.com/intl/en/scholar/inclusion.html>.
3. Buat juga profil jurnal Anda di sini <http://scholar.google.com>. Berikut ini contoh profil Google Scholar untuk jurnal Buletin Penelitian Kesehatan.

#### Applying for your journal to be in DOAJ

For a journal to be included in DOAJ, it must go through the new application process. Due to the nature of the information that we require to process an application, only publishers or journal owners may apply for their journal to be included. If you would like to see a journal listed that is not yet included in the DOAJ, contact the publisher and ask them to fill in the application form.

The new form requires a lot of information and completing it will take time. It will require you to collect all the necessary information before you start making your application. At this time, you are unable to save the form and come back to it later. We are working on a solution to facilitate that.

The new application form has been extended to enable the DOAJ team to make a comprehensive assessment of the journal's quality and dedication to Open Access. Each journal application is carefully assessed by a member of the DOAJ Team. Each of the 42 answers provided may be verified manually and this important process takes time. We therefore ask you not to chase journal applications as answering these emails takes time and stops us processing applications.

Any email sent about an application that is less than 3 months old will not be answered.

#### Journal Application Form

If you know a journal that should be included in DOAJ, please ask its publisher to complete this form.

We provide some guidance on the information we are looking for but that list is by no means exhaustive. Applicants are simply encouraged to complete the form clearly and honestly. If you do not know the answer to a question, you can request help by contacting us.

Currently, it is not possible to save your progress or for us to send you a confirmation email. We have created a spreadsheet version of the form and some other tips to help you. Guides to completing the form are available in [other languages](#).

The form is divided into two main sections: 'Basic Journal Information' and 'Quality and Transparency of the Editorial Process'.

**Basic Journal Information:**

- 1) Journal Title \*: [Input field]

- 4) Journal ISSN (print version) \*: [Input field]
- Only provide the print ISSN if your journal has one, otherwise leave this field blank. Write the ISSN with a hyphen (-).

- The journal must have either an editor or an editorial board with at least 5 clearly identifiable members and affiliation information. We may ask for affiliation information and email addresses as part of our checks.

## Cara agar Terindeks di Scopus

Perhatikan hal-hal di bawah ini:

1. Disarankan agar jurnal yang akan diajukan ke Scopus telah terindeks di Google Scholar dan DOAJ.
2. Perhatikan content policy dan selection criteria dari Scopus pada tautan di sini <http://www.elsevier.com/online-tools/scopus/content-overview#content-policy-and-selection>
3. Lebih fokus lagi, perhatikan kriteria minimum untuk terindeks di Scopus yaitu

### Journal selection criteria

To be considered for review, all journal titles should meet all of these minimum criteria:

- Consist of peer-reviewed content and have a publicly available description of the peer review process
- Be published on a regular basis and have an International Standard Serial Number (ISSN) as registered with the ISSN International Centre
- Have content that is relevant for and readable by an international audience, meaning: have references in Roman script and have English language abstracts and titles
- Have a publicly available publication ethics and publication malpractice statement
